# Submission Requirements

- (1) Completed nomination form
- (2) Resume and/or biography on the nominee
- (3) Written narrative about the nominee which addresses the following weighted criteria:

**Evidence of Leadership (20%).** Awards and recognitions. Leadership positions in both work and volunteer involvement. Promotions, titles. Success and growth of business or organization. Initiative in starting something. Challenging the status-quo. Inspires by sharing a vision, enabling others, modeling the way, and sharing the credit. (200 words or less)

**Expertise in selected award category (10%).** Exhibited and been recognized for exceptional professional contributions. Recognition in line of work by coworkers, bosses, etc. Excellence in her field of expertise. (100 words or less)

**Path to Success including Obstacles (30%).** Success achieved despite great obstacles. Has a story about overcoming barriers and obstacles or persevering along the path to success; story sets her apart from others who have achieved, but without same obstacles. (300 words or less)

**Community Service (10%).** Contributions to the community for the last ten years over and above services for which one is paid. Organization leadership positions. Service awards/recognition. Impact on improving the quality of life for others. Compassion. Empathy. Volunteerism. (100 words or less)

**Role Model to Other Women or to Others (20%).** Character, strong ethics, compassion, empathy. Actions have benefited those who have come after. Balance. Mentoring and helping others help themselves. (200 words or less)

**Legacy to the Community (10%).** Leaving a lasting impact on the community which survives the individual through excellence in the field of expertise and/or excellence in improving the quality of life for others. (100 words or less)
